AGREEMENT TO FOLLOW DIRECTIONS AND POSTED SAFETY PROTOCOLS: I agree to observe and obey all posted rules and warnings, safety markings in the break space and further agree to follow any oral instructions or directions given by Wreck Creation - Break Room, LLC, and its owners, the employees, representatives or agents of Wreck Creation - Break Room, LLC (collectively "Wreck Creation - Break Room, LLC"). Minor children must be accompanied by an adult while in the break cage at all times. **Initial** _____

ASSUMPTION OF THE RISKS AND RELEASE: I agree that the participation of myself and my dependents is voluntary. I recognize that there are certain inherent risks associated with the above described activity. Such risks include (but are not limited to) flying and floor debris, slipping and falling hazards, limited space of the room, sharp and unsmooth edges, shocks, stress, vibrations, acts and omissions by other people, environmental conditions, failure of equipment, physical exertion, unusual and odd physical stresses, loud noises, exposure to paint and paint covered surfaces, exposure to allergens/contaminants and other risks not specifically mentioned by name. I assume full responsibility for injury to myself and (if applicable) my dependents, and further release and discharge Wreck Creation - Break Room, LLC for all injury, loss or damage arising out of my or my dependents' use of or presence upon the facilities of Wreck Creation - Break

Room, LLC, whether caused by the fault of myself or my dependents, Wreck Creation - Break Room, LLC or other third parties. Initial_____
